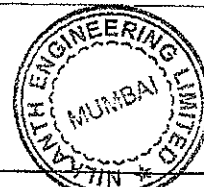
**Notes:**

- The Consolidated and Standalone results were reviewed by the Audit Committee and approved by the Board of Directors at their meeting held on February 12, 2021.
- The Statutory Auditors of the Company have carried out a Limited Review of the results for the quarter/nine months ended December 31, 2020 and have issued an unqualified review report.
- This statement has been prepared in accordance with companies (Indian Accounting Standards) Rules, 2015 (Ind AS), prescribed under section 133 of the Companies Act, 2013 and other recognised accounting practices and policies to the extent applicable.
- The Company is primarily engaged in the Investment activities and all other activities revolve around the main business of the Company. Further, all activities are conducted within India and as such there is no separate reportable segment, as per the Ind AS 108 "Operating Segments" specified under Section 133 of the Act.
- The Company's Financial Assets as on 31.03.2020 was not more than 50% of the total assets and income from financial assets was also not more than 50% of the gross income during the Financial Year 2019-20. Therefore, the Company was not satisfying principal business criteria during the FY 2019-20, the principal business of the Company has ceased to be that of a NBFC in terms of Press Release No. 1996-99/1269 dated 08.04.1999 issued by the RBI. Hence, as desired by RBI, the Company has surrendered its Original Certificate of Registration issued by the RBI and that the principal business of the Company is no longer that of a NBFC. Accordingly, financial results for the quarter/nine months ended December 31, 2020 is presented as per the format applicable to Non-NBFC Companies.
- COVID-19 outbreak declared as a global pandemic by the WHO has continued to spread rapidly leading to extension of nationwide lockdown with minor exemptions and quarantine measures stalling economic activity. The Company has been in operation with minimal permitted staff. The Company has not faced any material adversity of its financial position as at December 31, 2020 and considering other relevant facts and circumstances existing as of that date, the Company does not anticipate any material uncertainties which affects its liquidity position and also ability to continue as a going concern. However, the impact of the global health pandemic may differ from that estimated as at the date of approval of the financial results and the Company will continue to closely monitor and material changes to future economic conditions.

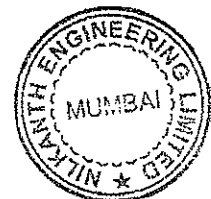

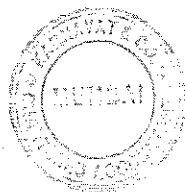
